Shinjuku Washington Hotel (hereinafter "the Hotel") has established the following Terms of Use regarding the use of the guest-only lounge SARYO (hereinafter "the Lounge").

To maintain a comfortable and safe environment, we reserve the right to ask guests to leave if they engage in prohibited acts or behavior that causes a nuisance to others. We appreciate your understanding.

[1] General Information

- Hours: 10:00 a.m. – 10:00 p.m. (Last entry: 9:00 p.m.)
- Use of the Lounge is restricted to staying guests only.
- Eligibility for Use

- Children aged 7 and older will be charged a fee of ¥3,850.
- Children aged 6 and younger may use the lounge free of charge.

[2] Usage Guidelines and Prohibited Acts

- Access may be restricted during busy periods.
- Please refrain from wearing guest room slippers or pajamas in the lounge.
- Avoid behavior that disturbs other guests, such as speaking in a loud voice or running.
- Please set your mobile phone to silent mode and refrain from making or taking calls.
- The lounge is a non-smoking facility. Guests who wish to smoke should use the designated smoking area on the 1st floor.
- Online meetings (such as Zoom) and video or voice calls are prohibited.
- Do not remove beverages, tableware, or other items provided within the lounge.
- Bringing in outside food or beverages, and the consumption thereof, is strictly prohibited.
- Please refrain from excessive drinking or using the facility while intoxicated.

- Do not engage in solicitation, religious or political proselytizing, commercial activities, distribution of flyers, persistent contact with other guests, or attempts to obtain personal information.
- Pets are not allowed, with the exception of service dogs.
- Please refrain from photography that inconveniences others or any unauthorized filming or photography, including the filming of other guests or staff members.
- Do not damage, soil, or move facilities and equipment without permission, or use them for anything other than their intended purpose.
- Avoid behavior that interferes with the duties of lounge staff, such as detaining staff members for extended periods.
- Do not monopolize facilities, equipment, or services for an unreasonable amount of time.
- Underage drinking is strictly prohibited by law.

[3] Denial of Service and Damages

The Hotel reserves the right to deny access or ask a guest to leave in the following circumstances:

- If a guest's behavior is deemed inappropriate for maintaining public morals, safety, or hygiene.
- If a guest is judged likely to violate laws, regulations, or public order and morals.
- If a guest is identified as a member of an organized crime group or other anti-social forces.
- In any other case where the Hotel deems the guest's use of the facility to be inappropriate.
- The Hotel bears no responsibility for any loss, theft, personal injury, or damage occurring during the use of the lounge, except in cases of willful intent or gross negligence on the part of the Hotel.
- If a guest causes damage to the Hotel or a third party, whether intentionally or through negligence, the guest shall be liable for compensation for such damages.
